



## PARTICIPATION AGREEMENT

This Participation Agreement (“Agreement”) is entered into on this \_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and between **Legacy Lacrosse Club, LLC dba Vanguard Lacrosse Club** (“the Club”) and the undersigned player and parent/guardian (“Participant”).

**\*by submitting registration, you agree to use the registration date submitted as the effective date of this agreement**

### 1. TERM OF AGREEMENT

This Agreement shall remain in effect for the duration of the club season beginning on the date of registration, 20\_26\_\_ and ending August 31st, 20\_26\_\_.

---

### 2. CODE OF CONDUCT

**Players agree to:**

1. Demonstrate respect for coaches, teammates, officials, opponents, and spectators.
2. Refrain from abusive language, taunting, or unsportsmanlike conduct.
3. Attend scheduled practices, games, and tournaments, arriving on time and prepared.
4. Communicate absences or conflicts to the coaching staff in advance.
5. Follow all safety rules and wear appropriate protective equipment.

**Parents/Guardians agree to:**

1. Support players, coaches, and officials in a positive manner.
2. Refrain from sideline coaching, arguing with officials, or disruptive behavior.
3. Direct concerns regarding playing time, policies, or team management through appropriate channels (Program Director).
4. Ensure timely arrival and pickup of players for all Club activities.

Failure to comply with the Code of Conduct may result in disciplinary action, up to and including Participant suspension or dismissal from the Club without refund.

**3. CLUB FEE**

The undersigned Participant and their parent or legal guardian agree to pay the club fee of **\$600** for the 2026 season. The club fee covers **all club-organized expenses**, including but not limited to:

1. Tournament and club entry fees;
2. Club pinnie (uniform) provided to the Player;
3. Coaching stipends for three (4) Club-appointed coaches;
4. Field rentals for practices and team events;
5. Balls and team training supplies;
6. Club operating expenses, including administrative and accounting costs.

The Participant acknowledges and agrees that **travel, lodging, meals, and personal equipment are not included** in the club fee and are the responsibility of the Participant and/or their parent or guardian.

Payment of the club fee confirms acceptance of these terms and grants the Participant the right to participate in all Club-organized activities for the 2026 season.

**4. REFUND POLICY**

1. All registration fees are **non-refundable** once the season has begun.
  2. Refunds prior to the season start may be considered only in cases of relocation, season-ending injury, or extraordinary circumstances, subject to Club approval.
  3. Any refund approved by the Club shall be prorated based on the timing of withdrawal and expenses already incurred by the Club.

## 5. MEMBERSHIP REQUIREMENT – USA LACROSSE

1. All players must maintain an **active membership with USA Lacrosse** throughout the season - \$35/year

  2. Proof of membership must be provided at the time of registration.
  3. Participation in any Club activities is contingent upon valid USA Lacrosse membership, which provides insurance coverage for both the Club and its participants.

## 6. WAIVER OF LIABILITY AND INJURY ACKNOWLEDGMENT

By signing below, the Participant and Parent/Guardian acknowledge and agree as follows:

1. **Assumption of Risk:** Lacrosse is a contact sport with inherent risks, including but not limited to sprains, fractures, concussions, or other serious injury. The Participant voluntarily assumes all risks associated with participation.
  2. **Release of Liability:** The Participant and Parent/Guardian hereby release, waive, and discharge Legacy Lacrosse Club, LLC, its directors, officers, coaches, volunteers, and affiliates from any and all claims, liabilities, or causes of action arising out of participation in practices, games, tournaments, or related activities.
  3. **Medical Authorization:** In the event of injury or medical emergency, the Club is authorized to seek emergency medical treatment for the Participant. All medical expenses incurred shall be the sole responsibility of the Parent/Guardian.
